Initiator of and responsible for several international PhD courses and master-classes (since 2002 and on). Initiated and responsible for the PhD course: Integrating phenomenology and qualitative methodologies which by now runs as a four-day course every year.

Responsible for and coordinator of several courses at IOB, between others theory driven courses covering phenomenology, learning and qualitative methodologies (Ba and Ma level), and practice-based courses in dance and martial art (Ba and Ma level).
