#### Vision for Education

I have taught in various subject areas and at different levels, from bachelor's and master's levels to elite groups, students with disabilities, and professionals working with the subject matter on a daily basis. I have conducted teaching either as regular classroom instruction or as lectures. Regardless of the level and teaching format, my focus is on establishing a connection with each individual and tailoring the teaching accordingly. I have taught/teach subjects such as personal data law, administrative law, criminal law, copyright law, and media law.

#### Student-Centered Approach & Active Learning

My vision for education is to actively engage and motivate students. In my experience, a one-way flow of information, i.e., traditional presentations, works better when followed by direct student involvement, allowing them to reflect, discuss, and interpret the material. For this purpose, I find it useful to prepare cases to present to the class, organize group discussions and case-based activities, or even role-playing exercises. Based on my experience, another simple and effective tool is to ask questions in class, and inviting discussions helps create a learning environment, placing students in a positive cycle of participation and learning. I believe it's important to help students understand the connections between topics within the field and enable them to comprehend the subject's role from a broader perspective.

#### Digital Learning

I frequently use digital tools to support traditional chalkboard teaching, such as the application Kahoot, where students can solve multiple-choice tasks collectively using their mobile phones. Whenever possible, I illustrate legal concepts with videos and audio; for instance, I obtained recordings from DR's archive for the analysis of key media-related judgments (Jersild and Sven Aukens have).

#### Research-Based Learning

The final pillar of my vision for education is that teaching, to the extent possible, should be research-based. This is an important aspect of the research itself but also benefits the students by ensuring that the instructor is well-informed and updated, actively publishing on the topics they teach.
