In addition, I am regularly active within executive education, and I have held various presentations on conferences and workshops. The repeatedly excellent student/participant evaluations of my lectures/presentations are my motivation to keep up and exceed my own teaching/presentation standards. I have received the *venia legendi* (lecturing qualification) in business administration from the University of Duisburg-Essen in May 2019.

Pedagogical skills acquisition plan

I strive to constantly improve my pedagogical skills and reach the highest standards in teaching. I am frequently reconsidering my teaching approach in my lectures and test out new approaches regularly. For this purpose, I keep myself updated regarding new and innovative teaching approaches. Furthermore, it is very important to me to consider student feedback to improve my teaching. To broaden my own pedagogical horizon, I intend to regularly participate in lecturer training programs, e.g. offered by the university or other institutions.
