## Teaching Portfolio

The ability to think about problems is an invaluable skill that can be used to succeed in a broad set of occupations, and I believe every student should be offered the opportunity to graduate with the ability to critically think. To achieve this goal within the accounting realm some of the teaching must be vocational, but a substantial part must be conceptual in nature. Accounting standards change, but critical thinking remains.

Students will learn most and best when they are intrinsically motivated and when they apply methods and theories on their own. Therefore, my role as a teacher consists in showing students why something is worth learning and to provide them with opportunities for self-learning. At the bachelor's level motivating accounting is easy – accounting is the language of business - but teaching requires more pedagogical considerations. At the master's level teaching is more conceptual and oriented towards research and critical thinking. This requires varying teaching methods such as lectures and exercises, group work, group presentations and cases.
