Teaching Philosophy

The main goal of my teaching is to provide Bachelor-, Master- and MBA-students with an engaging, challenging and well-founded education within the field of Business Strategy and Management. The knowledge, skills, and competences developed through these courses enable students to analyze relevant and practical problems in a well-structured manner, understand highly complex situations, and thereby develop actionable solutions and decisions. While theoretical principles are the foundation of each course, it is also very important for me to provide students with practical knowledge, experience and analytical tools as well as the ability to make use of the existing empirical evidence in their decision making.

My current teaching at University of Southern Denmark allows me to integrate teaching approaches, such as problem-based learning, blended learning, and experiential learning of which case-based teaching is a cornerstone of my teaching. In each lecture I use practical examples from the business press or smaller case studies, that are related to the thematic content of the respective lecture with the aim to demonstrate the practical relevance of the specific topic in question.

Moreover, I use my huge network to firms and practitioners to include at least one guest lecture in each course. I also use short case studies, tutorials, as well as e-learning modules to put students in a situation in which they have to utilize and to internalize business concepts and tools that were introduced in the lectures.

I completed the CBS' Lecturer Training Program in May 1987. Lately, I have followed a number of didactic courses in blended learning, e-learning and teaching in English.
