## Pedagogical idea

As a university teacher, I see it as my main task to conduct research-based teaching. In my view, this entails that I am an active researcher in the subjects I teach, that I use research-based teaching materials, e.g. research papers from acknowledged research journals, but also that I have an obligation to communicate what research in accounting and auditing is and how it can be conducted.

To achieve this goal it is necessary to have some tools to involve the students and make them familiar with relevant methods. However, it must also be acknowledged that an essential prerequisite for learning is to have an overview of the subject, as well as being introduced to the relevant methods used to solve problems. In the auditing area, with a comprehensive amount of regulation, it is therefore also necessary, that the students are introduced to the relevant issues of auditing and the underlying considerations and background for the regulations.

In my teaching, I therefore seek to present the core problems, as well as methods for solving the problems to the students, while making sure that they are able to work with the problems themselves and hereby be active, both in classes/during lectures and between classes/lectures. I do this by continuously including small tasks during my teaching, e-learning, as well as by including cases and previous exam questions in the teaching, to give the students opportunity to work with the problems themselves.
